PRESIDENT- MIKE LHOTSKY

This month's meeting with management was very different from the past meetings. This month seven of your board members were present to meet with ELS Vice President Greg Kane, along with Taunya, James and Matthew. Greg did most of the talking, as we wanted to hear his perspective on our situation. He did agree that the bulkheads have outlived their life span and need attention. He also expressed the opinion that he shares the same desire as we do to make this community one of the best places to live in the area. That being said, I feel that they, ELS are committed to fixing the problems we are currently experiencing. My only concerns are HOW and WHEN they decide to accomplish this task.

Ever since we began this process of receivership, ELS has had a change of heart. They have begun to hear our complaints and react to them. A lot of violations have been noted and things around the community are changing for the good of the community. But, compared to the Bulkheads and Drainage issues, these are the little things.

We did ask what they were doing to fix some of the drainage issues and as we were being specific. James was jotting notes on his laptop. This was again a sign they are hearing what we say. One other positive you may have seen in the community was Harry Caswell's Jetting truck. They were jetting and filming the conditions of the drains to detect any problems with the intent to fixing any problems. This was pointed out by the board, as we noticed the flapper valves were not functioning properly and we feel this was a step in the right direction to solve some of the issues of the past.

Greg has also told us that ELS has applied for a permit to cover all the bulkheads in the community, which to me means once the work starts again it should not stop and we can put this pain behind us.

With that being said, we have not and will not stop the process we have started. I do not see the work being done yet and will not let up until the job is done.

On a much happier note, we received permission from Management to again start using the clubhouse for activities. Barbara and Maria will provide you with the information of all planned events. I would like to ask you all to support us in these events and they will keep doing them. It's all about building a community and a happy place to live.

A lot of work goes on behind the scenes for all these things to happen. We need all of you to stand up behind us or join us in our quest to make this the best community in the area. We will be holding elections of new officers in the next couple of months (August) and none of this would be possible if no one stepped up. So please consider two things...join the HOA and volunteer to make a difference.

To date, we have 190 members. There are 350 homes in the community. It would be nice to sign up everyone, but that is asking a lot. Give it some consideration if you have not yet joined because together as a unit, we can accomplish much more than we can by ourselves. It's only \$20.00 a year and it is the best \$20.00 you will ever spend.

VICE PRESIDENT – LANIE WOOD

Please make your recycling count. There are some items that are not acceptable in Delaware's recycling program. At this point, the following items are not recyclable in Delaware and should be placed into a trash container:

Paper— Shredded paper, paper towels, napkins, tissues, paper plates, paper cups, coffee cups, hardcover books, wax paper, tissue paper, bubble envelopes, Fed-Ex envelopes (ty-vex), receipts

Paperboard — Frozen food packaging, refrigerated packaging (box from butter, etc), ice cream containers

Corrugated Cardboard — Greasy pizza boxes

Plastic Containers — **Plastic bags**; bubble wrap; and plastic film packaging from paper towels, toilet paper, water bottles, etc. (take back to retail store), motor oil and chemical containers, potato chip bags, plastic plates, plastic utensils, plastic straws, plastic packaging (blister packaging), plastic toys, plastic furniture, plastic hangers, small pill bottles

Styrofoam — Plates, cups, egg cartons, take out containers, peanuts, packaging material (clean Styrofoam can be dropped off at a DSWA facility)

Metal — Scrap metal, metal hangers, pots, pans, bottle caps, aerosol cans, paint cans, electronics, household batteries, extension cords, string lights

Glass — Mirrors, window glass, glass cookware, glass drinkware, lightbulbs

Food Waste — Rinse all containers of food and liquid residue

Yard Waste — leaves, grass clippings, branches

Any of these items found in recycling cans will cause the load to go to a landfill, thus negating the purpose of recycling. Thanks for your help in keeping Delaware green.

BOAT YARD - ED OLLIS

Thank you to all the HOA members that are using the boat yard for watercraft and trailer storage. It is great that so many of the members are taking advantage of this amenity. However, I do have to remind everyone that the summer storage comes with a \$35 storage fee. This fee is used to cover the cost of the ground maintenance such as grass cutting and the labor it takes to move the watercraft and trailers for the maintenance. In addition, all watercraft and trailers are required to have the HOA member's name affixed to the trailer. While many of you have already paid for your storage and made sure your names are affixed to the trailer, there are still many that have not.

If you have not already paid your annual HOA fee plus your summer boat yard storage, I urge you to pay your fee(s) through the HOA PayPal account or contact Al Wentworth, who is the HOA Membership person or myself. Our contact information is located on the front of the Beacon.

All storage fees must be paid by July 15th. After this date, any watercraft or trailer whose HOA fee and storage fee(s) is not paid will be removed from the lot. If your name is on the trailer, we will tow it to your home. If the trailer is not marked with a name, it will be removed from the boat yard and placed on the main road. From this point the watercraft or trailer will be subject to the rules of property management.

We sincerely hope that we won't have to take this action, but in fairness to all of the members that have paid their fees and for those volunteers that give their time to assist with moving the watercraft /trailers for ground maintenance, we feel we will have given everyone more than sufficient time to pay their HOA fee and summer storage payment(s).

lemon-honey cupcakes

FOR THE CUPCAKES:

2¾ cups all-purpose flour
¾ teaspoon baking powder
¾ teaspoon baking soda
½ teaspoon salt
½ cup reduced-fat sour cream
¼ cup milk
1½ tablespoons grated lemon zest
¼ cup fresh lemon juice
¾ cup (1½ sticks) unsalted butter, at room temperature

¾ cup honey

¼ cup sugar

3 large eggs

FOR THE FROSTING:

1 cup (2 sticks) unsalted butter, at room temperature
¼ cup honey
½ tablespoons grated lemon zest
4 cups confectioners' sugar
7 to 8 teaspoons lemon juice
Few drops of yellow food color

1. Heat oven to 350°F. Line two standard 12-cup muffin tins with cupcake liners.
2. In a bowl, whisk together flour, baking powder, baking soda, and salt. In a second bowl, whisk together sour cream, milk, lemon zest, and lemon juice.
3. Using an electric mixer, beat butter, honey, and sugar in a large bowl until light and fluffy, about 2 minutes. Beat in eggs, one at a time.
4. Reduce mixer speed to low and beat in half the flour mixture, then all the sour cream mixture. Add remaining flour mixture and blend until combined.
5. Spoon about ¼ cup batter into each of the prepared muffin cups and bake until a wooden pick inserted into the center comes out clean, 18 to 20 minutes. Let cool for 10 minutes, then transfer cupcakes to a wire rack to cool completely.
6. Now make the frosting: Using an electric mixer, beat butter, honey, and lemon zest in a large bowl until combined, about 2 minutes. Reduce mixer speed to low and beat in confectioners' sugar. Add lemon juice and food color and beat until fluffy and pale yellow. Spoon into a large ziptop freezer bag, snip off a corner, and pipe onto cupcakes.




