## PRESIDENT- MIKE LHOTSKY

I would like to start off by wishing everyone a safe and healthy SPRING. Things seem to be changing for the good (except gas and food prices). With these changes, we are trying to get back to normal with events as they used to be. Many activities will be taking place as we move into spring. Please support us if you can. Planned activities will be mentioned later in the publication.

The subject everyone wants to know about is "What's going on with the bulkheads?" We have been told by top management that work will begin early in summer, hopefully by June. What I understand is that the funding for the project has been approved and we are waiting on the contractor who has to secure the materials and equipment to start the job. It has been a long journey that we have been on to get this problem solved and I think we have turned a corner in the process. ELS said they will replace every bulkhead and heights will be established to meet the projections of rising seas in the next 10 years. Thank you for your support and patience over these past years.

Another item Important to our community is enrollment into the HOA. As of this time, Al tells me we have 129 members. That is about 25 more than this time last year. This is a great number but we still have a way to go. There are 350 houses in the community and we need to get everyone involved in the organization. It only cost \$20.00 a year if paid by April 15th. Our number one priority is to protect the rights of homeowners on leased land. With the membership in our HOA, you are also a member of the statewide organization DMHOA. They are the group that fights for your rights with legislation, without them we would be at the mercy of the land owners. So please consider joining if you have not yet done so. We will be holding our annual membership drive on **Saturday, April 9th** at the Clubhouse from 10:00 am until 1:00pm. Also, that day we will be serving free Hot Dogs, Soda or Water and chips to all who attend. Stop by even if you have already signed up. In addition to getting protection, you also get a Picnic with food and entertainment, which by the way will be held this year on June 25<sup>th</sup> and a holiday Dinner at Christmas time all at no expense to you and your family or friends. What a deal!!!! Please take the time and sign up on April 9th and help us become the largest HOA in Delaware.

Another subject that I have been made aware of is some of us have not turned in the Information sheet that the office has sent to all. This process helps identify potential problems and gives them an accurate picture of who is in the community. This is important for security as well as keeping the records correct. If you do not know what I am referring to, please stop in the office and ask to fill out the information sheet they sent to everyone. Having the correct information in the office helps everyone in the community. When problems arise, we can notify the correct people saving time and money for all. Keeping the community safe is all our jobs and working with the office is important to make this happen.

Thank you for your support over the past years. MARINERS COVE is a great community because we work together to make it happen. Thanks for that.

## **VICE PRESIDENT – TOM SIMONELLI**

The CPI-U continues to increase. The CPI-U is now out for February@ 3.61%. This is the 3-year average of February 2020, 2021 & 2022 and is what is used to determine our rent increase.

DMHOA continues to work with our legislators on a new bill that would better define the definition of capital improvements vs maintenance as well as negotiating a more fixed methodology of determining land owner raising rents.

Just to let our residents know, only the persons named on the lease are covered by Delaware law. That means if you purchased your home without signing a lease with the office, you are not protected. Another consideration, if all persons on the lease are no longer among the living, whoever inherits the home will have to apply & qualify for a new lease which would be at market rent not the rent that was being paid. An easy way to prevent this is to have whoever would inherit the home added to the lease while the current leasee is still alive.

I am looking forward to Spring and hopefully some good boating and fishing as management begins bulkhead replacements.

April showers bring May flowers and with that brings Summer. The word is the bulkhead project will begin in early summer but talk is cheap and we have heard it all before. Actions speak louder than words and for every action there is a reaction. No action will bring the reaction of taking them to court and letting the judicial system handle this ongoing situation. We will hold a meeting at the clubhouse **May 10<sup>th</sup> at 7pm**. I hope we can count on additional dog lovers to plan our park.

## A WORD FROM THE OFFICE

What's going on and what you need to know!

Check your snail mail and emails for upcoming news from the Chicago office, concerning bulkheads, updated rules and regulations for the community and new payment procedures.

Paper checks, money orders will no longer be accepted at the office or through the mail. You will need to sign into the community portal and have your rent electronically sent or sign-up for Automatic Payments with Karen.

This will all be laid out in notifications that will be sent to you. This would be a good time to be sure the office has your correct email address.

If you need help setting up or resetting your password on the portal, Matt or Karen will be happy to help you.

Bulkheads: a news update was recently emailed to residents. A vendor has been selected to do the work and is tentative for a summer start. Once contracts are finalized communication will be sent out to the residents. Marina's will remain closed due to the project and staging areas.

Fencing: On the west side of the community is in sad shape and Matt is waiting on final approval on the replacement project. This might be a 2nd phase project between 2022 & 2023.

Fitness room: the floor has been replaced and a company is on call for any repairs needed for the equipment. Contact the office for the Fitness Room access code.

Cove Drive Paving (Marina Side): Will have another 1.25" of overlay put down in Late April/Early May.

Cove Drive Drainage (Office side): A Contract is in the works to install 3 new catch basins between Joann Drive and Knoll way to help alleviate lake Joann. Work is expected to be complete by the end of 2022.

Landscaping: A new company has been hired to do the work and will begin mid-April.

Driveways, mud and water: Please call the office to have stone dropped off to aid in this problem. It is the responsibility of management to help residents with this problem, this pertains to the end of the driveways. Areas from the top of driveway to the street are the responsibility of the resident.

Pet issues: All pets outside must be attended by their owner/resident. Any issues with neighbor's pets should be reported to Animal Control and the office should be notified of the issue.

If there is an incident of biting, PLEASE notify the office AND Animal Control.

Dog waste bags are now available at the designated spot (across from mail boxes) Please use them and you will need to dispose of the bag at your home.

Sewer bills: Residents actually have 2 sewer bills. An annual Sewer Maintenance bill, typically due in April and a Sewage Usage bill paid to Sussex County every quarter.

If you don't pay directly to Sussex County by the strict due date, the office will receive the bill, pay it and then charge you a fee in addition to the bill.

Private Home Sales: You need to reach out to the office even if you are using a realtor. Exterior home inspection is required before putting on the market.

Pool and lifeguards: A new company has been hired and along with that the hours have changed. The pool will now be opened from 11am to 7pm.

That's all for now. Please know I have asked Matt to give me the time to talk about what is going on and what folks need to know, especially if you are new to the community. Please note that certain projects may be delayed due to various reasons. Hopefully this part of the Beacon will be helpful to you. ## BOAT YARD – ED OLLIS

One of the amenities afforded to Mariner's Cove Homeowners Association Members is onsite watercraft and trailer storage. Since our lease rules only allow for one watercraft to be stored on our property site, having an onsite boat yard available for storage of additional watercraft and/or trailers can alleviate the problem for those homeowners having more than one watercraft or trailer.

For our new HOA members, the boat storage lot is located at the foot of Knoll Way and is only available to currently paid HOA members on a first come first served basis. The fee for using the storage area for either a boat or trailer is \$35 **per** boat or trailer and covers **both** winter and summer storage. We collect this fee to pay the volunteers for the lot maintenance. **Watercraft storage reservations and fee payments**

**for the 2022/2023 boating season will begin May 1st and must be paid by June 30<sup>th</sup>.** Storage payments received **after June 30** will be **assessed a \$5.00 late fee**. Any member who is not a currently paid HOA member will be denied lot storage until their HOA fees are current and the storage lot fees paid.

The following are the steps for securing watercraft storage:

Step 1: Be sure you are a **current and paid HOA member for 2022/2023 season**.

Step 2: **Ed Ollis must be contacted** for boat storage reservation. **No watercraft or trailer is to be placed in the storage lot or on the adjacent road without a prior reservation.**

Step 3:

- Storage fee is to be paid by **CHECK ONLY; made payable to: MCHOA**
- **Storage Fee Per Watercraft or Trailer: \$35 each**

Payments accepted starting: **May 1**

Final date for payments: **June 30**

\$5.00 late fee applies: **after June 30**

#### **Step 4**

##### **WATERCRAFT AND TRAILER IDENTIFICATION**

- All boats and trailers in storage **must have proper identification:**
- **Owner's name and address listed prominently on the watercraft/trailer.**
- **Trailers must be ID labeled on the tongue of the trailer.**
- **Watercraft must contain an ID label on the front of the boat or jet ski.**

##### **IMPORTANT REMINDERS**

- **In order to take advantage of watercraft storage, all the steps listed above must be adhered to.**
- **Any watercraft and/or trailer found in the lot without BOTH proper identification and unpaid HOA fees will be removed from the lot.**

### sweet potato, black bean, and spinach quesadillas



- |   |  |

| 2 small sweet potatoes, halved lengthwise | 1 15-ounce can black beans, rinsed                             |
| 2 tablespoons olive oil                   | 1 bunch spinach, thick stems discarded, leaves roughly chopped |
| 2 cloves garlic, finely chopped           | 4 medium tortillas   |
| 1 teaspoon ground cumin                   | 6 ounces monterey jack cheese, coarsely grated                 |
| ¼ teaspoon ground cinnamon                | Lime wedges and salsa, for serving                             |
| ¼ teaspoon cayenne                        |  |

**1.** Heat broiler. Line a large broiler-safe baking sheet with foil. Place the sweet potatoes on a plate, cut-side down, and microwave on high until tender, 5 to 7 minutes.

**2.** Heat the oil and garlic in a large skillet over medium heat until the garlic just starts to sizzle. Stir in the cumin, cinnamon, and cayenne, and cook for 30 seconds.

**3.** Add the beans and ¼ cup water and cook, tossing occasionally, until heated through, about 2 minutes. Add the spinach and cook, tossing until it just begins to wilt, about 1 minute; remove from heat.

**4.** Place the tortillas on the prepared baking sheet. Scoop the sweet potato from the skins and spread on one half of each tortilla. Top with the bean mixture and cheese, then fold over the tortillas to cover the filling (they will look overstuffed). Broil until the top is golden brown and the cheese has melted, about 2 minutes. Serve with lime wedges and salsa, if desired.

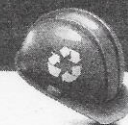

## RECYCLE INFORMATION

**Acceptable items** should be placed loose, empty, clean and dry into a curbside recycling cart. **Paper:** Magazines, catalogs, junk mail, envelopes, office paper, newspapers, paperback books, paper bags, phone books, wrapping paper (no foil paper), notebook paper. **Paperboard:** Cereal boxes, snack food boxes, paper towel rolls, toilet paper rolls, paper egg cartons, paperboard envelopes. **Corrugated Cardboard:** Corrugated shipping boxes and packaging cartons. **Plastic Containers:** (with caps/lids on. No need to crush) Milk cartons, juice cartons, chicken broth cartons, coconut water cartons, juice boxes, coffee creamer, egg beaters cartons, narrow neck bottles: water, juice, and soda bottles; shampoo and mouthwash bottles; detergent bottles; bleach bottles: plastic tubs yogurt containers, butter containers, plastic jugs (milk jug), plastic clamshell containers (strawberry container) **Cans:** (no need to crush) - Aluminum beverage cans, soup cans,, pet food cans, clean aluminum foil and foil pans **Glass Bottles and Jars:** (Remove tops from glass jars and recycle both items), Glass bottles (any color), beer bottles, wine bottles, soda bottles, glass jars.

### **Not recyclable in Delaware and should be placed into a trash container:**

**Paper:** Shredded paper, paper towels, napkins, tissues, paper plates, paper cups, coffee cups, hardcover books, wax paper, tissue paper, bubble envelopes, Fed-Ex envelopes (ty vex), receipts. **Paperboard:** – Frozen food packaging, refrigerated packaging (box from butter, etc.), ice cream containers. **Corrugated Cardboard:** Greasy pizza boxes. **Plastic Containers - Plastic bags:** bubble wrap; and plastic film packaging from paper towels, toilet paper, water bottles, etc. (take back to retail store), motor oil and chemical containers, potato chip bags, plastic plates, plastic utensils, plastic straws, plastic packaging (blister packaging), plastic toys, plastic furniture, plastic hangers, small pill bottles. **Styrofoam:** Plates, cups, egg cartons, take out containers, peanuts & packaging material (clean Styrofoam can be dropped off at a DSWA facility). **Metal:** Scrap metal, metal hangers, pots, pans, bottle caps, aerosol cans, paint cans, electronics, household batteries, extension cords, string lights. **Glass:** Mirrors, window glass, glass cookware, glass drinkware, lightbulbs. **Food Waste:** Rinse all containers of food and liquid residue. **Yard Waste:** leaves, grass clippings, branches. **Plastic bags and film** do not go in your recycle bin, because they get tangled in the machines at the material recovery facility. Return empty plastic bags and film to retail store's collection bins. Plastic film includes the plastic that covers cases of water bottles, paper towels, etc.
